D. HIPAA only module: Health Insurance Portability and Accountability Act (HIPAA) is specific to health care based institutions such as hospitals, medical offices and research centers. These modules are integrated into the Investigators & Staff Basic Course & Refresher course and therefore do not need to be repeated. Researchers who complete Human Subject Research training through association with a non-healthcare related institution may be required to complete this module.
